

**ORDINANCE NO. 834**

**AN ORDINANCE AMENDING THE CITY CHARTER REGARDING THE OFFICE OF MAYOR PRO-TEM AND PROVIDING FOR THE SUBMISSION OF THE ORDINANCE TO A VOTE OF THE REGISTERED ELECTORS AT THE NOVEMBER 7, 2017 REGULAR ELECTION.**

**WHEREAS**, Section 2-11 of the City of Dacono Home Rule Charter provides the City Council shall appoint from among its members a Mayor Pro-Tem at the first regular or special meeting following each regular election; and

**WHEREAS**, certified election results are often not received by the time the first regular or special meeting is held after each regular election, and therefore newly elected Councilmembers have not yet assumed office; and

**WHEREAS**, the City Council finds the appointment of a Mayor Pro-Tem should take place after certified election results have been received, so that newly elected Councilmembers are able to participate in such decision; and

**WHEREAS**, the Home Rule Charter further requires the Mayor Pro-Tem to assure the City Council meets at least once each year with each board and commission established by the Charter to discuss matters of mutual interest; and

**WHEREAS**, the City Council finds that such requirement should be removed from the Home Rule Charter, so the City Council may meet with boards and commissions only as often as the efficient conduct of City business may require.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DACONO, COLORADO:**

**Section 1.** Section 2-11 of the City of Dacono Home Rule Charter is hereby amended to read as follows (words to be deleted are ~~stricken through~~; words to be added are underlined):

**Section 2-11. Mayor Pro-Tem.**

At the first meeting, regular or special, following ~~each regular election~~ certification of election results, the Council, by at least four (4) affirmative votes, shall appoint a Councilmember as Mayor Pro-Tem for a one (1) year term. The Mayor Pro-Tem shall have the Mayor's powers and perform the Mayor's duties whenever the Mayor is not available. The Mayor Pro-Tem shall also serve as the Charter and Code liaison, tracking the status of periodic Charter, Municipal Code,

personnel policy and capital improvements program reviews required by this Charter, ~~and ensuring that the City Council meets at least once each year with each board and commission established by this Charter to discuss matters of mutual interest.~~

**Section 2.** Section 11-11 of the City of Dacono Home Rule Charter is hereby amended to repeal subsection (h).

**Section 3.** The charter amendment provided for herein shall be submitted to a vote of the registered electors at the November 7, 2017 regular municipal election to determine whether the amendment shall take effect.

**Section 4.** The charter amendment provided for herein shall not take effect unless and until a majority of the registered voters voting at the November 7, 2017 regular election vote “yes” in response to the following ballot title:

**SHALL THE CITY OF DACONO HOME RULE CHARTER CONCERNING THE MAYOR PRO-TEM BE AMENDED TO PROVIDE THE COUNCIL SHALL APPOINT FROM AMONG ITS MEMBERS A MAYOR PRO-TEM AT THE FIRST MEETING FOLLOWING CERTIFICATION OF ELECTION RESULTS, AND TO ELIMINATE THE REQUIREMENT THAT THE MAYOR PRO-TEM ENSURE THE CITY COUNCIL MEETS WITH ALL CITY BOARDS AND COMMISSIONS AT LEAST ONCE EACH YEAR?**

**Section 5.** If any article, section, paragraph, sentence, clause, or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each part or parts hereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.


**Section 6.** All other ordinances or portions thereof inconsistent or conflicting with this Ordinance, or any portion hereof, are hereby repealed to the extent of such inconsistency or conflict.


