

ORDINANCE NO. 930

AN ORDINANCE REPEALING AND REENACTING SECTION 2-1 OF THE DAcono MUNICIPAL CODE CONCERNING MAYOR AND COUNCIL COMPENSATION AND PROVIDING FOR THE SUBMISSION OF THE ORDINANCE TO A VOTE OF THE REGISTERED ELECTORS AT THE NOVEMBER 8, 2022 REGULAR ELECTION.

WHEREAS, by Ordinance No. 250 adopted on June 22, 1981, compensation for the Mayor was established as \$75.00 per month and compensation for each Councilmember was established as \$50.00 per month; and

WHEREAS, at the election held on April 5, 1994, the registered electors of the City of Dacono approved the Dacono Home Rule Charter; and

WHEREAS, Section 2-4 of the Charter provides that elected officials shall receive such compensation as may be prescribed by ordinance, and that no increase in such compensation shall be effective until approved by the registered electors of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DAcono, COLORADO:

Section 1. Section 2-1 of the Dacono Municipal Code is hereby repealed and reenacted to read as follows:

Section 2-1. Mayor and City Council – Compensation.

(a) The Mayor shall be paid a monthly salary of five hundred dollars (\$500.00).

(b) Councilmembers shall each be paid a monthly salary of three hundred dollars (\$300.00).

Section 2. The repeal and reenactment of Section 2-1 of the Dacono Municipal Code provided for herein shall be submitted to a vote of the registered electors at the November 8, 2022 regular municipal election to determine whether the same shall take effect.

Section 3. The repeal and reenactment of Section 2-1 of the Dacono Municipal Code provided for herein shall not take effect unless and until a majority of the registered voters voting at the November 8, 2022 regular election vote “yes” in response to the following ballot title:

SHALL COMPENSATION PAID TO THE MAYOR BE INCREASED FROM \$75.00 PER MONTH TO \$500.00 PER MONTH, AND SHALL COMPENSATION PAID TO EACH CITY COUNCILMEMBER BE

**INCREASED FROM \$50.00 PER MONTH TO \$300.00 PER MONTH,
WITH SUCH INCREASES TO TAKE EFFECT FOR ALL SUCH OFFICE
HOLDERS ON JANUARY 1, 2023?**

Section 4. If any article, section, paragraph, sentence, clause, or phrase of this ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The City Council hereby declares that it would have passed this ordinance and each part or parts hereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.

Section 5. All other ordinances or portions thereof inconsistent or conflicting with this Ordinance, or any portion hereof, are hereby repealed to the extent of such inconsistency or conflict.


